We, the undersigned, Archimandrite EMMANUEL PAISIOS LOULOURGAS, residing at 36-07 23rd Avenue, Astoria, New York, and Archimandrite VASILIOS VIKENTIOS MALAMATENIOS, residing at 36-07 23rd Avenue, Astoria, New York, being respectively the presiding officers, namely, the President, and the Clerk of St. Irene Chriso valantou Greek Orthodox Monastery, and the members thereof, for the purpose of procuring the incorporation of the same pursuant to the provisions of Section 15 of the Religious Corporation Law of the State of New York, execute and acknowledge this certificate as follows:

FIRST: The said St. Irene Chrisovalantou Greek Orthodox Monastery is an unincorporated governing and advisory body of the Greek Orthodox Faith.

SECOND: At a meeting of said body, at which a quorum was present, duly held at 36-07 23rd Avenue, Astoria, New York, on August 30, 1977, it, by a resolution duly adopted by it, determined to become incorporated under the laws of the State of New York under the name ST. IRENE CHRISOVALANTOU

CERTIFICATE OF INCORPORATION

We, the undersigned, Archimandrite EMMANUEL PAISIOS LOULOURGAS, residing at 36-07 23rd Avenue, Astoria, New York, and Archimandrite VASILIOS VIKENTIOS MALAMATENIOS, residing at 36-07 23rd Avenue, Astoria, New York, being respectively the presiding officers, namely, the President, and the Clerk of St. Irene Chriso valantou Greek Orthodox Monastery, and the members thereof, for the purpose of procuring the incorporation of the same pursuant to the provisions of Section 15 of the Religious Corporation Law of the State of New York, execute and acknowledge this certificate as follows:

FIRST: The said St. Irene Chrisovalantou Greek Orthodox Monastery is an unincorporated governing and advisory body of the Greek Orthodox Faith.

SECOND: At a meeting of said body, at which a quorum was present, duly held at 36-07 23rd Avenue, Astoria, New York, on August 30, 1977, it, by a resolution duly adopted by it, determined to become incorporated under the laws of the State of New York under the name ST. IRENE CHRISOVALANTOU

GREEK ORTHODOX MONASTERY, Incorporated.

THIRD: At the said meeting the said body, by unanimous vote of its members, also elected three persons, whose names and addresses hereinafter are stated, to be the first trustees of such corporation.

FOURTH: The name by which such corporation is to be known is: ST. IRENE CHRISOVALANTOU GREEK ORTHODOX MONASTERY, Incorporated.

FIFTH: The objects for which such corporation is to be formed are: To edify and promote the religious and moral life of the Greek Orthodox Faith Christians in the America and to supervise and advise and maintain authority over churches created under its auspices and to purchase churches, conduct religious schools and other community affairs, and to conduct and operate a monastery dedicated to the principles of the Greek Orthodox Faith. No part of the net earnings of the corporation shall inure to the benefit of any private shareholder or individual.

SIXTH: The number of trustees of the corporation shall be three.

SEVENTH: The names and post office addresses of the first trustees of such corporation, as elected by the said

body, as aforesaid, are as follows:

EIGHTH: The principal office of the corporation is to be located in the County of Queens, City and State of New York; but branch offices thereof may be maintained and its functions may be exercised in any part of the Americas.

NINTH: The monastery shall conduct religious services pursuant to the cannons of the Julien Calendar of the Eastern Orthodox Faith. The Old Calendar Monastery shall conduct and maintain services at a location where a large population of Greek people reside.

IN WITNESS WHEREOF, we have executed the foregoing instrument this 31st day of September, 1977.
